Paper proposal

Abstract	Up to 350 words, including: a) A clear statement of the research question; b) A brief information on the theoretical/conceptual framework used; c) Major research areas to which the paper relates.

Session proposal

Sessions can be ninety minutes long (usually three papers, a commentator, and a panel chair) or two hours to accommodate four papers. A successful session leaves significant time for the audience to raise questions and comments. Tracks may combine up to three sessions (e.g., a whole afternoon) to allow for a broader discussion of a specific approach or theme important to the field. Track sessions expect the audience and the presenters to engage in a wider discussion.
